## Codirex' Privacy Statement

Codirex considers the careful handling of personal data a vital component of its mission. It goes without saying that we adhere to legislation and regulations including the General Data Protection Regulation (Algemene Verordening Gegevensbescherming (AVG)) and treat all data of customers, suppliers and other stakeholders as confidential.

### Processing personal data

Codirex processes personal data for the benefit of its provision of logistic services.

We process personal data in the context of customers, suppliers, applicants according to the set purposes and legal grounds that have been further fleshed out per component in this privacy statement. The data processing and retention period are limited to what is considered necessary and are specified per component.

### Customers and suppliers

We process the following personal data of customers and suppliers:

- name
- address details
- telephone number
- e-mail address

The basis for this processing is the agreement we have concluded with customers and suppliers. The personal data of customers and suppliers is processed for administrative purposes and for the execution of the agreement.

The retention period of the relevant personal data is for the execution of the agreement and subsequently at least 7 years based on the legal fiscal retention period.

### Applicants

Data relating to the application is only used for the purpose for which it was provided, namely the recruiting of staff for the benefit of the execution of our services. We delete your application data no later than 4 weeks after the closing of the application term.

We request your consent when we would like to retain application data for a longer period, maximal 1 year after the closing of the application period.

To all our transactions and activities the Dutch Forwarding Conditions are applicable, incl. the arbitration clause, as deposited by FENEX at the Registry of the District Courts at Amsterdam and Rotterdam, latest version. Dutch law applies. Claims, based on article 23(1) Dutch Forwarding Condition, that Codirex Expeditie BV may bring into court are settled exclusively by the competent Dutch court of Rotterdam.
